and wells. Our water source is groundwater. We have three wells, two are located in the park, the third is in the southwest part of town. These wells are supplied by the Siluruan Devonian Aquafur. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs

Possible contaminants in source water might include:

- systems, agricultural livestock operations, and wildlife. Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic
- Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides which may come from a variety of sources such as agriculture, storm water runoff, and residential uses
- Organic chemicals, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic
- Radioactive materials, which can be naturally occurring or be the result of oil and gas production and mining activities
