ORDINANCE NO. 5 OF 2022

AN ORDINANCE AMENDING THE WATER RATES AND CHARGES FOR THE USE OF AND SERVICES RENDERED BY THE WATERWORKS OF THE TOWN OF FRANCESVILLE, INDIANA

WHEREAS, the Town of Francesville, Indiana ("Town") now owns and operates a municipal waterworks in accordance with the provisions of Title 8, Article 1.5 of the Indiana Code, and acts amendatory thereof and supplemental thereto, furnishing the public water supply to said Town and its inhabitants; and

WHEREAS, the Town Council of the Town ("Town Council") adopted Ordinance No. 10 on December 2, 2019 ("Ordinance") establishing the current rates and charges for the use of and services rendered by the waterworks of the Town; and

WHEREAS, the Town Council finds that the rates and charges established by the Ordinance are insufficient to enable the Town to properly operate its waterworks plant, provide for depreciation, service its bonds, and finance additions and improvements to its waterworks system; and

WHEREAS, the Town Council finds that the rates and charges of the waterworks should be increased and that it is necessary to amend the Ordinance and repeal the rates and charges set forth therein to the extent they conflict with the rates and charges set forth herein; and

WHEREAS, the Town Council finds that the rates and charges set forth herein are reasonable and just to provide service to the customers of the waterworks;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FRANCESVILLE, INDIANA, THAT:

Section I.
Section 1A of the Ordinance is hereby amended and restated as follows:

Section II.
Section 1B of the Ordinance is hereby amended and restated as follows:

B. Minimum Charge

Each user shall pay a minimum charge accordance with the following applicable size of meter installed, for which the user will be entitled to the quality of water set out in the above schedule of rates.
